Musical Instrument Hire Agreement – 2022

Instrument Rentals is a music instrument hire service offered to students and adults who don't want to bear the cost of purchasing an instrument. The terms and conditions are set out below and by signing this agreement you are consenting to all them. All instruments remain the property of Instrument Rentals (referred herewith as 'IR'), regardless of how long you hire the instrument for. There is no rent to buy option available.

TERMS AND CONDITIONS

Responsibility

- All instruments hired must be taken care of under the guidelines given for each instrument.
- It becomes the responsibility of the signatory of this contract to ensure that the instrument is stored correctly and be alert to any potential risk areas where it may be damaged or stolen.
- In the event of loss of instruments (or any part of the equipment provided) the hirer will be responsible for the full replacement cost and will reimburse the owner (IR) for the full current cost of replacing the equipment.
- The hirer will either pay for repair or compensate Instrument Rentals for the full cost depending on the extent of the damage. Repairs must only be carried out by recognised instrument repairers. No attempts to repair a damaged instrument are to be made by the hirer

Payment & Deposit

- Full deposit and first month's rental instalment must be cleared or have accompanying POP before equipment will be issued.
- Payments will be made by EFT.
- Deposits will be returned in full once instruments have been returned and tested, unless deductions have to be made due to instrument damage.
- Instruments are rented and billed by the month. Instrument Rentals will assume the hirer intends to carry on renting the instrument if it has not been returned, and be billed accordingly.
- Part month hire constitutes a full month's hire for billing purposes.

Deliveries & Collection

- Delivery and collection of instruments will be on the account of the hirer.
- If the hirer wishes IR to deliver instruments IR will add the delivery charge on to the first month's rental cost.
- All goods are checked before packing. It is the hirer's responsibility to alert IR timeously of any issues with the equipment so as to avoid being held liable for any damage.
- There will be no charge for collection and safe return of instruments.
- Equipment returned must be properly vetted and receipt issued so as to have a record of handover. If there is no proof of handover then the hirer will remain liable for the equipment.

Equipment

- All Instruments will be issued in good working condition.
- Damage to instruments will be charged to the customer and deducted from the deposit. Greater payments will be due with immediate effect.
- Accessories required for certain instruments will be to the account of the hirer.
- Accessories that already belong with the hired instrument, if any, must be returned with the instrument to IR.

Owners right to cancel

- IR reserves the right to terminate the contract and collect the equipment with immediate effect if the hirer is facing bankruptcy or liquidation.
- The hirer grants IR rights to access any place where the equipment may be situated for collection/removal.
- IR is not responsible to the hirer for any loss of liability suffered in the event of contract termination and equipment collection/removal.
